I am directed to say that it is proposed to fill up the post of Director General in the Competition Commission of India, New Delhi, an office under the administrative control of the Ministry of Corporate Affairs. The particulars of the post, scale of pay, and the eligibility requirements, have been set out in Annexure-I.


2. The person selected will be appointed on transfer on deputation basis. The pay will be regulated in accordance with the Department of Personnel & Training's OM No.2/29/91-Estt (Pay-II) dated 05.01.1994, as amended from time to time. The period of deputation shall not exceed 5 (five) years.

3. It is requested that this vacancy circular may kindly be given wide publicity and applications of eligible and willing officers, whose services can be spared immediately on selection, may kindly be forwarded through proper channel in the prescribed proforma at Annexure-II (in triplicate) duly accompanied by the following documents, to the undersigned within thirty days from the date of issue of the circular for appointment:-

- (i) Verification of the particulars of the officer from his service record, including vigilance clearance certificate, in the prescribed proforma, appearing at the end of Annexure-II;
- (ii) Attested photocopies of the up-to-date Annual Confidential Reports for the last five years;
- (iii) Integrity Certificate duly signed by an officer not below the rank of Deputy Secretary;
- (iv) Certificate to the effect that no major/minor penalties have been imposed on the official during the last ten years duly signed by an officer not below the rank of Deputy Secretary;

4. Applications received after the last date, or incomplete in any respect or those not countersigned or not accompanied by the documents/information as mentioned in para 3 above, would not be considered. The vacancy circular is also available at the website of this Ministry i.e. www.mca.gov.in.
