NOTICE FOR INVITATION OF APPLICATION FROM DIFFERENT AGENCIES FOR EMPANELMENT BY THE HON'BLE HIGH COURT OF DELHI FOR SEARCHING ASSETS OF VARIOUS COMPANIES (IN LIQUIDATION) AND WHEREABOUTS OF THE EX-DIRECTORS.

The Office of the Official Liquidator, Delhi, situated at A2, W2, Curzon Road Barracks, Kasturba Gandhi Marg New Delhi, is attached to the Hon'ble High Court of Delhi and entrusted with task of dealing in liquidation proceedings of various companies (In Liqn.) under the Companies Act, 1956 and Rules framed thereunder under the supervision of Hon'ble High Court of Delhi.

The Hon'ble High Court of Delhi considering the fact that a large number of cases of companies in liquidation, the ex-directors and the assets of the Companies (In Liquidation) are not traceable for long time. Therefore, the Hon'ble High Court of Delhi has been pleased to make a panel of the willing agencies having sufficient experience in the field for searching and investigating the ex-directors and assets of the companies in Liquidation that are not traceable.

Accordingly applications from willing agencies having sufficient experience in the field are invited for searching and investigating the ex-director's whereabouts and assets of the various Companies in liquidation that are not traceable. The Hon'ble High Court of Delhi shall make the panel after scrutiny and selection from amongst the applicants who apply for undertaking the said task. The Hon'ble High Court of Delhi shall fix the fee for the above said job once the report is placed before the Hon'ble High Court of Delhi about the number of such applicants who are willing to be empanelled for the said purpose.

INTERESTED AGENCIES HAVING SUFFICIENT EXPERIENCE IN THE FIELD ARE REQUESTED TO FURNISH THEIR APPLICATIONS INDICATING TERMS & CONDITIONS IN DUPLICATE ALONGWITH THEIR EXPERIENCE IN THE FIELD SO AS TO REACH THE OFFICE OF OFFICIAL LIQUIDATOR DELHI ON OR BEFORE 31.10.2008.
